# Title:Digital Service Tax (DST) and Value Added Tax (VAT) Registration for digital<br/>service provided by Non-Resident Person.

Purpose: TO DEFINE THE METHODS AND RESPONSIBILITIES FOR DST AND VAT REGISTRATION PROCESS UNDER THE SECTION 20 OF FINANCE ACT, 2022 AND SECTION 10 B1 OF VALUE ADDED TAX ACT, 1996.

Finance Act 2022 has introduced Digital Service Tax on Digital Service provided by Non Resident Person to the Consumers of Nepal. Digital Service Tax shall be levied at the rate of **2%** of the transaction value of digital service (value excluding indirect tax levied in Nepal).

Scope: This procedure applies for Digital Service Tax and Value Added Tax Registration.

**Responsibilities:** The **Taxpayer** is responsible for providing all information required for DST registration as required by IRD regulation. Taxpayers can use e-filling or fill up prescribed forms and submit to the Large Taxpayer Office (LTO).

**Tax Officers** are responsible for ensuring the correctness and adequacy of the information provided by the taxpayer and verification of the registration.




