5. Bidders must submit their bids electronically through **PPMO e-GP portal** <http://www.bolpatra.gov.np> on or before **2078 Jestha, 28 at 12:00 PM.** Documents received after this deadline shall not be accepted.
6. The e-Submitted bids shall be opened in the presence of bidders' representatives who choose to attend on **2078 Jestha, 28 at 2:00 PM** at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal.**

The Bidders, who choose to deposit the bid security in the form of cash, the cash should be deposited in District Treasury Controller Office, Lazimpat, Kathmandu, Deposit Account No.: **1100203000000**, **Office Code No : 305043501**, at Rastriya Banijaya Bank, Thamel Branch and submit the receipt of the deposited amount of cash along with the bid.
