1. The **Inland Revenue Department** has annual program towards the cost of Procurement of **The Supply, Delivery, Installation and Commission of Server** to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible Bidders from all countries
2. The **Inland Revenue Department** invites *electronic* bids from eligible bidders for the procurement of **The Supply, Delivery, Installation and Commission of Server** under National competitive bidding – Single Stage Two Envelope procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) **the Technical Bid** and the other (ii) **the Price Bid**, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

5. Bidding documents can be downloaded for e-submission from PPMO's e-GP portal <http://www.bolpatra.gov.np/egp>. Bidders should deposit the cost of bidding document in the account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of e- bid submission.

6. Pre-Bid Meeting **3 June 2025 at 2:00 PM pm Inland Revenue Department, Lazimpat.**
7. Bidders must submit their bids electronically through PPMO e-GP portal <http://www.bolpatra.gov.np> before **18 June 2025 at 12:00 Noon**. Bids received after this deadline will be rejected.
8. The e-Submitted bid shall be opened in the presence of bidders' representatives who choose to attend on **18 June 2025 at 2:00 PM** at the office of **Inland Revenue Department, Lazimpat, Kathmandu, Nepal**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid

security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 6,60,000.00 (Six Lakh Sixty Thousand)**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **120 days**)

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
